If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®. ***I agree that, if accepted for Membership in the Board, I shall pay the fees and dues as from time to time established.
